1st Reading:

MOTION TO APPROVE amendments to Chapter 6 of the City's Code of Ordinances relating to the Alcoholic Beverages.

There are a few modifications to the Ordinance that need to be amended that were inadvertently omitted from the re-write or that will offer better clarification.

1. Add Section 6-2 (e) The Alcoholic Beverages Fees, Fines and Charges Resolution will be kept on file in the Office of the City Clerk.

- 2. Section 6-53 insert package outlet before pouring outlet.
- 3. Section 6-53 amend sections (3) and (4) to change 10:00 a.m. to 6:00 a.m., insert "otherwise" between as provided, and delete "in subsection (9) herein as there is no (9).
- 4. Section 6-53 (6) add "licensed" before sidewalk
- 5. Section 6-53 add section (8) It is unlawful for any licensed establishment to sell, pour or serve alcohol on Thanksgiving Day or Christmas Day.
- 6. Section 6-56 (d) add "licensed" before sidewalk

The change included in amendment 3 is based upon the licensed establishment's review of the new ordinance that was delivered. The previous ordinance language was ambiguous and they have apparently been selling as of 6:00 a.m. This is a Council policy decision in terms of the time change.

Agenda Item # 6: Councilmember Holcomb **MOTION TO APPROVE** the appointment of Brandon Bowen of Jenkins and Bowen to serve as the City's Solicitor for the Adairsville Municipal Court.

The City does not currently have a solicitor and as a result the police officers serve as prosecutors for municipal court. This item is consistent with the City's Charter and Mr. Bowen has proposed a flat rate of \$550.00 per month. As Solicitor there is prep for court and only the officers that have a case where a trial has been requested will be required to appear.

The Chief has advised that we currently spend approximately \$800.00 per month on overtime. While there will still be some expense related to a part-time officer transporting those from jail to appear in court, this action should reduce the overall expense.

Staff will evaluate the effectiveness of this approach over the next 3-6 months and make recommendations if necessary.

The City Attorney has reviewed the proposal and supports with a 3-6 month evaluation.
